Waiver and Release



Each of the undersigned, being fully aware of the risks inherent in ballroom dancing competitions and exhibitions, as a condition to participation in ICON DANCESPORT (the "ICON") as the organizer of the ICON as follows:

- 1. Injury and Loss:
- -I assume all risks of bodily injury (including death) inherent in participating in the ICON and all risks of loss or theft of or damage to any property of mine suffered while attending the ICON, including, without limitation loss of any articles left in any ballrooms, changing rooms

or hotel rooms (together, the "Risks").

- I release the ICON, its owners, officers, agents, and employees from all liability to me, my personal representatives, assigns, heirs, and next of kin as a result of the Risks, and agree to hold harmless Releasees against any claim or cause of action, damages, costs and expenses which I or anyone claiming by, through or under me may at any time have against Releasees arising out of the Risks.

2. Adherence to Rules:

- -I agree that I shall be bound by the rules of the ICON appearing on its website and automatically become obligated to adhere to such rules by participating in this event.
- 3. Television and Media Exposure:
- I irrevocably grant to ICON and to its licensees, assignees, and other successors-in-interest (together, "Grantees") the right to photograph and record (in any medium whatsoever) my performance, appearance, name and/or voice at the ICON (the "Reproductions"), to edit and arrange the Reproductions at its discretion; to use and to license others to use the Reproductions in any manner or media whatsoever, including without limitation unrestricted use for purposes of publicity, advertising and sales promotion in connection with the ICON, the products or services of any sponsors thereof; and for any other purpose, anywhere in the world.
- I waive all rights and release and forever discharge Grantees from, and shall neither sue nor bring any proceeding against any such parties for any claim, demand, or cause of action, whether now known or unknown, for defamation, invasion of right to privacy, publicity or personality or any similar matter, or based upon or relating to the use and exploitation of the Reproductions.
- 4. Legal Capacity: I am 18 years of age or older and am executing this agreement as a condition to competing in the ICON or as the parent or legal guardian of and on behalf of a competitor who is under 18 years of age and has full right, power, and
